

## **Correcting your Birthright Political Status!**

The Maine Assembly is one of the 50 American State Assemblies working to restore our lawful government the way our Founders intended it to be, before the fraud, corruption and deceit became rampant and out of control.

Unfortunately, we have been taught that a U.S. Citizen or a citizen of the United States is the same as an American State National. However, it is not true and is part of the propaganda and lies that perpetuate the fraud, corruption and deceit of the current government. Someone with the political status of a U.S. Citizen or a citizen of the United States does not have the same rights or protections as someone who has the political status of an American State National. This fraudulent system unlawfully converted Americans to a different political status at birth (U.S. Citizen and/or citizen of the United States) in order to usurp the people's rights, liberty and pursuit of happiness.

The current government does not disclose the different rights and protections of the different political statuses because it would expose the fact that the current government is fraudulent and not accountable to the people. The reason being is because it is not a true government, but an incorporated entity or franchise that deceitfully copy-cats a name, is run by a board of directors and Chief Executive Officer, and is responsible only to the shareholders and the bottom line.

For example, the Federal Reserve System sounds like a government agency but in fact it is a private corporation that controls the entire monetary system of our country.

Alfred Crozier (1863-1939), in his book "U.S. Money Vs. Corporation Currency. Aldrich Plan: Wall Street Confessions! Great Bank Combine" attempts to warn us stating, "... by far is the most daring and dangerous scheme ever introduced into Congress."

We have been facing a similar problem today, in that our fraudulent government have proliferated and promoted their citizenship(s) as separate political statuses, and have created false registrations as U.S. Citizens and citizens of the United States in our names without our knowledge or consent.

Once again, the need to declare our political status as Americans via The 1779 Naturalization Act is of the utmost importance at this time. The 1779 Declaration document is utilized so Americans, both those born within the physical borders of the States, and those who have been Naturalized as United States Citizens, may establish and/or re-verify their political status by recording their Declarations with their State Assemblies.

To correct and reclaim your birthright political status as an American State National on Maine, you need to have been living on Maine for more than 1 year and one day. You will also need 2 Witness Affirmation Forms completed by adults that have known you for 7 years or more, a copy of your Birth Certificate (if you have Naturalization papers or a Green Card you will also need to have them available) and a copy of the Declaration of Political Status form (do not autograph this form at this time).
